

You can be kept in hospital because Section 5(2) of the Mental Health Act 1983 says so.

You have been placed under Section 5(2) of the Mental Health Act 1983. This leaflet is to help you understand what this means.

The Mental Health Act 1983 is a law. A law is like a rule.



# How long will I be in hospital?

## What happens next?

You can be kept in hospital for 72 hours. This is 3 full days.

The doctor will say when you can leave hospital.



If you try to leave before the doctor says it is ok, you can be stopped.



If you leave hospital before the doctor says it is ok, You will be given a leaflet about this law if you you will be brought back.

You will be examined by another doctor.



The doctor will decide if you still need to stay. If the doctor decides you need to stay you will be examined by another doctor and a social worker.



Another part of the law called the Mental Health Act 1983, will allow your doctor to keep you in hospital longer.

The doctor may say it is ok for you to leave hospital. The doctor or your social worker will ask you what help you need when you leave.



If a second doctor does not examine you before the end of 3 days you can leave or stay in hospital.



Talk to your doctor about what you want to do.



The doctor will tell you about the treatment you need to get better.
